NABIP FL AWARDS GUIDE

Welcome to the NABIP Florida Awards Guide. The information in this guide is designed to help you successfully apply for NABIP Florida Awards each year. As the local Awards Chair for your chapter, you have a big role in your chapter. At the beginning of each award year, you should work with your Chapter President to plan activities specifically designed to earn points for each award. Prior to the awards submission deadline, consult your Chapter President and Board to decide who will be nominated for each award.

If you have questions throughout the year, please reach out to the NABIP Florida Awards Chair. If you're not sure who this person is, you can check the NABIP Florida website, <u>www.nabipfl.org</u> or ask the NABIP Florida Executive Director at <u>info@nabipfl.org</u>. Date joined NABIP can be found in eCommerce and the state of Florida website will show date of licensure.

Requirements:

In order to receive points for a specific item, documentation must be submitted. Failure to submit the documentation will result in points not being counted. Examples of documentation include but are not limited to copies of sent emails, meeting minutes, agendas, newsletters, outside recognition, thank you letters received, newspaper articles, press releases. In addition, award submissions received without the original application form will not be accepted.

Timeframes:

The qualification period for *all* NABIP Florida Awards is July 1 to June 30 each year. All submissions must be received by midnight on July 20 via email. If July 20 should fall on a Sunday, then submissions will be accepted on Monday July 21. This date could vary from year to year, so please watch for details from NABIP Florida.

Rules:

Only NABIP Florida members are eligible. Executive assistants and directors of the association are eligible only at the nomination by their employing board for activities above and beyond their paid responsibilities. Please write accomplishments in a way that can be used to present the award to your nominee.

Selection:

All Award Recipients are selected by the NABIP Florida Awards Committee which carefully reviews all applications and documentation submitted. In making its selection, the committee looks for contributions above and beyond the call of duty without regard to personal gain. Nominations must be supported by accompanying statements that detail the accomplishments of the candidate. Award Recipients will be announced at the Annual NABIP Florida Awards Event.

Barbara Coggins Volunteer of the Year Award Application

The nominee for this award should be an individual member who volunteers at least 30 hours per year to our association through dedicated service at the STATE level. In addition, the Volunteer of the Year also knows the importance and value in giving his/her time to other organizations and charities. Barbara Coggins was a member of FAHU for over 30 years, at the time of her passing in June 2022. She was President of the Central Florida chapter in 1997-1998 and of FAHU in 2000-2001. Barbara's energy & passion influenced and encouraged many to get into leadership in our association. She was also very involved in organizations outside of FAHU. Only one recipient per year. An individual may only receive this award once every five years. The qualification period for this award is July 1-June 30.

The Scott Robertson Legislative Excellence Award Application

Scott Robertson was very highly regarded as a leader in FAHU. After serving as President of the Southwest Florida Chapter, Scott served as the FAHU Legislative Chair both before and after serving as FAHU President. Scott encouraged local legislative chairs to attend state board meetings and he also pushed FAHU to contract an Association Manager for the first time. Scott was killed in a motorcycle accident on the racetrack on 11/29/15. Scott was an avid racer and motorcycle enthusiast. This award is intended to recognize a member who went above and beyond with their legislative efforts on behalf of the association. One recipient per year and member can only receive once every 5 years. The qualification period for this award is July 1-June 30.

Steve Israel Commitment to Leadership Award

Application

The nominee for this award should be an individual member who has served in leadership positions at the local, state and regional or national level for a minimum of five years. Steve Israel was a member of the Palm Beach (formerly Palm Coast) chapter for 15 years, serving on his chapter's board for 13 of those years. He also served on the FAHU board for nine years including as President in 2017-2018. As FAHU President, Steve was responsible for the holding of FAHU's first Medicare Summit. Additionally, Steve served multiple years on NAHU's Media Relations Committee & Medicare Advisory Group. He was an eight-time LPRT Qualifier and received the Triple Crown Award twice. Creating an award in Steve's honor was an easy decision after his passing in September 2021. Those who knew and served with Steve, knew him to be extremely ethical, to show love for all and to rarely say no, when asked to help. One recipient per year and member can only receive once every 5 years. The qualification period for this award is July 1-June 30.
