

Board Meeting Minutes

Call to Order by President, Angela Mlynarski at 12:09pm. Quorum was established.

Dave Sherrill read the anti-trust statement.

Motion made by Morgan Campbell to approve minutes from December Meeting, Chris Kinley seconded the motion. All in favor, minutes approved.

President's Report – Angela Mlynarski

Thank you to all for being here and a personal thanks to Corey for pulling everything together and his great communication to all for making this Day on the Hill happen. We're working on the name change, just waiting on the state, but we're on top of everything.

Treasurer's Report - Josh Hoppe

Financial reports were distributed. Josh reviewed them and noted that we have double the assets of what we had this time last year. \$111,582.08 on hand compared to \$55,731.01. \$5,000 debt was paid off earlier this year. We have \$2,000 that was contributed by chapters for Hurricane Ian relief that is showing as a Current Liability. Funds will be returned to the chapters if not needed. Overall, in very good shape considering funds for Symposium are just not starting to roll in.



Executive Director Report – Dave Sherrill

Since our Zoom meeting in December, I have worked with Morgan and Ken on putting the 2023 Symposium Sponsor Brochure together and once it was finalized, I sent an email blast to last year's sponsors as well as several additional prospective sponsors. I've processed the first sponsorship form submitted by Diversified Administration. I will also be working on building the registration site and am working with the committee on all of the other aspects of this event.

I filed the name change paperwork with the state on 12/11. Per their website as of 2/3, they are currently processing Corporate Amendments received on 11/7, so we probably have another 5-6 weeks before they get this processed. I won't be able to change the bank account until after the state approves the change.

I put together and distributed the December and January Newsletters with Brittany's assistance in gathering content, and I am working on February's, which will hopefully go out by the end of this week.

I sent a new sign-in sheet out to all of the chapter presidents for tracking meeting attendance for 2023. I've started a new spreadsheet and have been compiling attendance for credit in 2023. Thank you to Tampa Bay and Capital Area for getting their attendee lists to me for January. Please send these to me after your chapter meeting each month, unless the program is already filed for CE.

I sent the bank statements for December and January to Josh to reconcile the bank accounts and confirmed that allis good. I ran the financial reports for this meeting and printed copies for those attending.

I worked with Ben Davis to create logos for each chapter using the NABIP name and shared them with the chapters.

I worked with Kenny at Kazoo Creative to create the new NABIPFL.org website and paid him the balance owed for the work he did. I am continually working with him to keep things up to date and had him create a landing page for the symposium, where the sponsor brochure and hotel booking link are currently available. He will be adding a banner add to the home page for this, once we get the graphics used for the sponsor brochure.

I redid the Tampa Bay Chapter bylaws to change their name to National Association of Benefits and Insurance Professionals Tampa Bay Chapter and sent them to Tammy and Clare to submit to NABIP with Tammy's signature. I also sent them a second version with suggested amendments to be considered.

I invoiced all of the chapters for the domain names that we secured for them. I've received payment from all chapters except for Jacksonville. Several of the chapters currently have the new domain addresses going to their existing websites. Central, Broward and Capital Area sites have been updated with the new name.



I invoiced all of the chapters for their share of the 2023 D&O insurance and have received payments for all of them except Jacksonville and Southwest.

I have been asked to run for NABIP Regional Vice President at the annual convention in New Orleans this summer. I will only do that if I have the full support of the Florida and Central Florida boards. I need endorsements from at least 3 chapters to get on the slate.

Carol will try to write some new courses for the school in a couple of months. 1 will be "There's More Than HIPAA" regarding potential fines and penalties that could be incurred. Don G. said he would like a course based on what can be said, that company staff claim they can't discuss due to HIPAA.

I will be unable to attend in this board meeting. My NABIP PAC Report is below including a giving list for NABIP FL 2022 leadership (attached). Many, many thanks to those that contributed!!

While I understand that each of us must choose careful how to use our limited resources, it seems to me that a contribution to NABIP PAC is warranted in some amount. If not, I would like to discuss with that individual the value of the organization.

As a chapter leader at NABIP, I hope all will lead by example (as most are doing!) and be one of the PAC's supporters. The average contribution to an Association PAC nationally is \$60/yr. The current average contribution to NABIP PAC is \$330/yr! As a leader, I think we should be above average.

Results from Last Year:

With many new faces in Congress, many need to be educated on the role of agents, brokers, and benefits specialists in our healthcare system. HUPAC's goal is to ensure NAHU continues being at the table when legislation and proposals are being discussed. Because of our success in fundraising we are increasing the funds we give to those in leadership, in committees of jurisdiction, and our legislative champions.

HUPAC broke our 2020 success record with a win rate of 93% this campaign cycle. HUPAC supported 218 federal candidates in the 2020-2022 election cycle. Of those 218 candidates supported, 201 were reelected to Congress while 17 lost their elections in the primary or general. From a dollar amount perspective, \$686,500 was disbursed to candidates in the 2022 cycle. Of the \$686,500 disbursed, \$635,000 went to winning candidates while \$51,000 went to losing candidates.

HUPAC supported 177 House members and 41 Senate members in their reelection campaigns last cycle. 113 of the candidates HUPAC supported were Republicans while 105 were Democrats. As a bipartisan PAC , HUPAC strives to give equally to candidates who support us and our issues.

In Region 5, HUPAC supported 27 candidates with 25 winning re-election. Also in Region 5, HUPAC supported 5 non incumbent candidates from Florida and Georgia and all 5 won election in their perspective races. We supported 18 Republicans and 9 Democrats in this region.

Rep. Scott Franklin, FL-15: attended a thank you reception for the Congressman. Former Navy fighter pilot serves on Armed Services but owned an insurance agency (recently allowed his license to lapse). Good friend to our locals during his days in the Florida legislature. Should be solid on healthcare issues for us.

FAHU-PAF Report -?

Angela stated that we're still having issues. She did speak with Bill Hepscher and he was going to reach out to Julian Lago to work on righting the ship. Vicky Major-Bell emailed Dave, that she's approving the PAC Managers expenses, but feels there needs to be an active board.

Julie and Vice-Chair, Mark Hicks have been reaching out to the chapter presidents to help get them at least Silver Certified. Angela wants every chapter president to utilize the support being offered by Julie and Mark. If all chapters get at least Silver certification, Angela will do something for them.

Benefits and Medicare Symposium Report - Morgan Campbell
