See updates each Friday in the NABIP Washington Update! Key NABIP Wins from 2024, highlighted in this week's edition:

- Employer Reporting
 - Provides much-needed relief for employers seeking to comply with the reporting requirements under Section 6055 and 6056 for enforcement of the ACA
- Mental Health Parity
 - NABIP's Mental Health Working Group authored a comment letter and members tirelessly met with Biden officials, members of Congress and committees, state regulators, the National Association of Insurance Commissioners, and insurance industry and employer coalition partners
- State-Level Defense vs Single-Payer and Public Option Proposals
 - 15 state bills were blocked, including single-payer proposals in CA and CO, and a public option proposal in MN, protecting consumers from higher costs
- Operation Shout and Member Advocacy!
 - 14 state-level Operation Shout! campaigns, amounting to 1,399 messages to legislators
 - 2 federal Operation Shout! campaigns, amounting to 2,811 messages to legislators
 - Over 6,000 advocacy survey results
 - 16 comment letters on the state level
 - 4 letters to Congress
 - Over 200 working group and regional meetings with NABIP members and staff focused on federal legislative and regulatory strategy
 - Nearly 100 NABIP staff meetings with legislators, regulators, and state commissioners
